Q2 – Summary of Activities

In the second quarter of Fiscal Year 2026, Bedford Community Access Television, Inc. continued to provide PEG services as well as offer training to those who live, work, study, or belong to an organization in Bedford.

PROGRAMMING

In this quarter, BCAT broadcasted 204 new shows, representing 214 hours of new content. Of these programs, 150 of them were locally produced for a total of 178 hours of content, of which 71 programs originally aired live to our YouTube channel before being rebroadcast on our cable channels. The news continues to record its weekly program, and classes are being offered for kids and adults to increase interest in more studio productions. All Select Board, School Committee, Board of Health, Finance Committee and Planning Board meetings will continue to stream live to our YouTube channels and broadcast live to our cable channels as well. Many locally produced shows were also hosted online on BCAT's YouTube channel "Bedford TV, MA."

In Q2 of FY 26, the Bedford TV YouTube channel had 41,200 views, representing a total of 6,500 hours of programming watched. The channel also gained 81 subscribers, bringing the total number of subscribers to 14,142. In Q2 some of our most viewed content on YouTube was our coverage of BHS sports games. Most games routinely had between 75 and 200 views with several having over 500 views. Our most viewed program in Q2 was Varsity Football vs Walpole in the MIAA tournament on November 7th totaling 2,159 views. The most viewed video produced by a Bedford TV member in Q2 was an episode of "Celebrate Life", totaling 306 views. Government meetings also continued to receive significant viewership on our YouTube channel. The total number of viewers varied considerably, with totals ranging from approximately 50 to 500 views, depending on the agenda items discussed.

Bedford TV has continued to go above and beyond the typical day-to-day duties of the station to support the needs of the Town and our volunteers. We have assisted many of the Town's departments, boards, committees, schools, and community organizations in sharing information via video so that they may engage with the community and encourage participation among town residents and continue to do so.

We have continued to share as many board and committee meetings as have been possible. In Q2, we recorded and streamed 27 government meetings. This includes the five boards listed previously as well as the Historical Society, both nights of Special Town Meeting, and community forums on a variety of

topics. By request of the board or committee chairs, we will also rebroadcast any additional meetings recorded on the Town of Bedford's Zoom account. Public Service Announcements from multiple different organizations and Bedford TV local producers continue to run during regular time slots on our public and government channels. We have also continued to update the Community Bulletin Board channel with relevant public health information, local organizational updates, and with all notices sent from the Town. Additionally, Bedford TV records the news weekly with stories from the Bedford Citizen to keep the community informed on what is happening around town.

Bedford TV played a significant role in helping community organizations share their events virtually with a wide audience. We live streamed, recorded, and edited several events happening around town including a Ribbon Cuttings for Pure Vida Caffe, Not Your Average Joes & Bedford Walnut Street Center, Trunk or Treat, Mike Rosenberg Press Box Dedication, Yellow Tullip Project, Pumpkin Smash, Kristallnacht, Veterans Day Ceremony, Flavors of Bedford, Tree Lighting, Rotary Holiday Breakfast, and more. Several of these events were live streamed while others were edited together into a news story and added to our weekly news program.

Bedford TV has also continued our sports recap segment and volunteer video packages in our weekly news show. Bedford TV volunteer, Dan Brosgol, gives a weekly update on BHS sports by talking over an edited sports package that is pieced together by one of our many student volunteers. Bedford TV also had multiple volunteer producers create new episodes of their shows and multiple podcast producers made new episodes of their respective podcasts. Lastly, the Bedford Common show continued to record its monthly episode highlighting what is going on with the Planning Board, Finance Committee, School Committee, and Select Board by representatives from each board. This show is completely produced by our student volunteers. Bedford TV also continued providing support to the Bedford Public Schools in Q2 of FY 26. Bedford TV recorded and live streamed 38 Varsity sporting events in the 2025 Fall Season and 2026 Winter Season. Viewers for these games have increased each year as our volunteers and staff improve every aspect of the games. This year Bedford TV's coverage of BHS sports is being sponsored by three community partners. The coverage of these games also run on our public channel.

PODCASTS

Bedford TV did not add any new podcasts in Q2 of FY26 but did have new episodes created by our dedicated producers. Starfish Storytellers, Delight in the Limelight, The Bedford Tavern, Lessons We Can Take from Today, and the Bedford Common continue to be recorded and aired on Bedford TV. A weekly one-night introductory podcast class started in December to attract new member produced shows in FY26.

OPERATIONS

Bedford TV did not have any staffing changes in Q2 of FY26. Many of our volunteer producers have returned to the studio and are creating new episodes of their shows. Student volunteers also continue to be heavily involved in recording on and off-site productions with the use of our studio and field production equipment.

Bedford TV did not have any interns during Q2 of FY 26.

TRAINING

Bedford TV held six classes during Q2 of FY 26 as shown in the data below. All these courses were offered in partnership with the Bedford Recreation Department. Bedford TV will continue to work with the Recreation Department and offer classes every Wednesday during the school year. These classes are run

by Bedford TV staff and assisted by Bedford TV student mentors. Our student mentors all have a minimum of 75 hours of community service at Bedford TV with most having over 250 hours and multiple having achieved over 1,000 hours.

Bedford TV also continued our success from last spring and is offering another Advanced Filmmaking course to our student mentors that started on September 24th. This class takes place over twelve weeks and is run solely by Bedford TV. During this class students will create their own short film from concept to completion. They are responsible for coming up with the idea, writing their script, finding actors and actresses, creating shot lists, scheduling filming, and editing the whole film together. A premiere screening for this class final project will be scheduled for some time in February.

Bedford TV also gave on-location training to volunteers during productions, as well as one on one help with editors at Bedford TV.
